

#### IMPORTANT NOTE: WITHDRAWAL AND FEE REFUND AFTER ONLINE ROUNDS OF COUNSELLING:


1. After depositing of Academic Fees, if a candidate wants to withdraw his/her admission against the allotted seat, he/she can apply for Online withdrawal by clicking on the withdrawal option available in his/her account in the admission website within the specified time period, following the online withdrawal procedure.
2. All candidates who have withdrawn, frozen their seat, not paid the Part Academic Fee of Rs. 60,000/- and who do not fulfill the eligibility criteria, will not be participating in the subsequent round of online counselling and the vacancies with respect to such candidates will be considered for allotment of seat in subsequent Rounds.
